



QUARRY DAYS 2024 GENERAL INFORMATION

Due to ongoing Manitoba Public Health Regulations in relation to COVID-19 all terms and conditions contained herein are subject to change depending on the Province of Manitoba Regulations leading up to and in place at the time of the event.

Please note there are **FOUR pages** that must be submitted in order for your application to be reviewed. Failure to submit completed forms will result in the immediate rejection of your application.

EXPLANATION OF VENDOR CLASS

Class A* – FOOD VENDORS IN PREMIUM MIDWAY LOCATIONS

Full service food vendors, chip trucks, etc... There are a limited supply of premium locations, based on the types of food sold (no vendors offering the same product) and the size of the space required.

Class B* – FOOD VENDORS – FOOD COURT LOCATION

All food vendors NOT located in the midway will be in the food court location.

*** CLASS A & B FOOD VENDORS: THE SALE OF COTTON CANDY, CANDY APPLES, HOT DOGS AND SMOKIES IS PROHIBITED.**

***We require a copy of a CURRENT VALID HEALTH PERMIT required from ALL FOOD VENDORS:** If unknown please contact the Public Health Inspector at (204) 822-2851. Non-compliance with health regulations will result in your removal from our festival. No refund will be issued.

Class C – RETAIL / NON FOOD SERVICE

Any vendor selling wares other than food (i.e. jewelry, trinkets, sunglasses etc., information booth for profit businesses). Please be sure to list all items that you sell/ service you provide. You will ONLY be permitted to offer what you have listed. We do our best to situate you so that you are not located next to someone offering the same product/service. We cannot do this if you do not detail your product/service. We reserve the right to limit the number of Vendors offering the same product/services. Only one home based business will be permitted per application.

Class D – LOCAL BUSINESS

Businesses with a mail or physical address within the Rural Municipality of Rockwood or the Town of Stonewall.

Class E – STONEWALL MAIN STREET BUSINESS

To be in this class you MUST have a storefront business located on Main Street in Stonewall. We will try and accommodate those who wish to set up on the street outside their business however due to street setup this is not always possible.

Class F – NOT FOR PROFIT / CHARITY

To be in this class you MUST be a registered not for profit or charity. The number of not for profits and charities will be limited due to street set up.

Please Note General: Contact information MUST BE PRINTED CLEARLY. Often, we cannot read phone numbers or email addresses on the forms. This will only delay confirmation of your acceptance. If you have an email address, please provide it to us. Email is our best mode of communication.

Vendors that require power/water will be given priority regarding location based on availability. We cannot guarantee that you will be placed in the same location as previous years.



There are no set 'hours' to Stonewall Quarry Days. Please refer to the schedule of events listed on our website at www.stonewallquarrydays.ca to determine when you would like to be open.

Pease Note Payment: Please be aware that all cheques will be deposited on receipt. This in no way guarantees your acceptance. If your application is denied, a cheque, in the full amount, will be sent to you within 30 days. If your application is denied, the decision is final. However, you may make application for the following year. There is a \$50 fee for any NSF cheques.

There will be a late fee of 20% of your total vendor fee if registering after June 30th. There will be a \$50 NSF fee for any returned cheques. There will be NO REFUNDS for vendors canceling after July 1st.

COVID-19

Cancellation: Should Stonewall Quarry Days have to cancel the 2024 festival due to Provincial COVID-19 restrictions or gathering limits, vendors who have already paid will be refunded in full within 30 days following cancellation.

Adherence to Restrictions: All vendors will be required to adhere to any and all Province of Manitoba COVID-19 restrictions in effect during the Stonewall Quarry Days weekend. Any vendors found to be in non-compliance with Provincial restrictions will be required to leave Stonewall Quarry Days grounds immediately - no refunds will be provided and vendor's participation in future Stonewall Quarry Days will be determined by the Stonewall Quarry Days committee. Vendors may be subject to fines and penalties by local enforcement.

Please keep in mind that Stonewall Quarry Days is a not-for-profit festival and is run entirely by volunteers who will do their best to accommodate your needs. We strive to make Quarry Days a positive weekend for all those involved. Thank you in advance for your understanding.

9. All food vendors are required to supply a copy of Current / Valid Health Permit. To obtain contact the Public Health Inspector at (204) 822-2851. Non-compliance with health regulations will result in your immediate removal from our festival. No refund will be issued.
10. I (we) understand that there will be absolutely no subletting of booth space.
11. I (we) understand here will be only one home based business per vendor application.
12. I (we) understand that Stonewall Quarry Days is a rain or shine event and that there will be no refund given for no shows or if a vendor chooses to tear down and leave the event early.
13. All booths must be free standing and may not be anchored into the community street. In addition, all items must remain WITHIN your space, no racks, tables, signs etc. may be placed in the sidewalks or walkways around your booth. No booths can be set up in any way to impede access from cross roads for emergency services.
14. The sale or display of any weapons of ANY type, drug or drug related paraphernalia of ANY kind is strictly prohibited. This includes, but is not limited to knives and novelty pipes.
15. Approved Vendors be advised you are responsible to provide adequate property and liability insurance coverage during your attendance. The Quarry Days Committee shall not be responsible for loss, damage or 3rd party injury incurred or sustained during your attendance. Stonewall Quarry Days does not provide any security. As such I (we) acknowledge that Stonewall Quarry Days, it's committee, volunteers is not responsible for any damage sustained to our vendor booth, display, product, vehicles etc. during our time at the event.
16. COVID-19: All vendors must comply with all current Manitoba Health Regulations. Non-compliance with health regulations will result in your immediate removal from our festival. No refund will be issued and vendor's participation in future Stonewall Quarry Days will be determined by the Stonewall Quarry Days committee. Vendors may be subject to fines and penalties by local enforcement.
17. COVID-19: Should Stonewall Quarry Days be required to cancel our festival due to COVID-19 restrictions, full refunds will be issued within 30 days of cancellation.

12:00 pm – 2:00 pm Friday: Food trucks and vendors with trailers ONLY

2:00 pm – 4:00 pm Friday: Vendors with tents & tables ONLY

Failure to attend for set up at your allotted time may make it difficult to position your truck or trailer, or you may be required to move your tent and tables. If you arrive earlier than your stated set up time you may be required to wait to set up.

ALL VENDORS MUST REPORT TO THE INFORMATION BOOTH PRIOR TO SETTING UP

Power Hook Up: We will try to have all vendors hooked up by 6:00 pm. If you require power prior to that please make alternate arrangements.
